## License Agreement

- **4.** If any part of the Certifications that you obtain is marked confidential, you agree to protect the confidentiality of that document.
- 5. PA AND ISO-NE ARE PROVIDING THE CERTIFICATIONS AS-IS, AND YOU ACCEPT THE RISK AS TO THEIR SATSIFACTORY QUALITY, PERFORMANCE, ACCURACY AND USE. PA AND ISO-NE DISCLAIM ALL IMPLIED WARRANTIES, INCLUDING THE IMPLIED WARRANTIES OF TITLE AND NON-INFRINGEMENT, MERCHANTABILITY, AND FITNESS FOR A PARTICULAR PURPOSE.
- **6.** You agree to defend, indemnify, and hold PA and ISO-NE and their officers, directors, employees, successors and assigns harmless from and against any and all liabilities, damages, costs, claims, expenses, settlements or other losses (including reasonable attorneys' fees and the expenses of other professionals) as incurred, arising from your use of the Certifications and/or a breach of this License Agreement.
- 7. You agree that, to the extent permitted by applicable law: (i) the total, aggregate liability of each of ISO-NE and PA arising from or related to this License Agreement, for any and all reasons (including negligence, strict liability, breach of contract, misrepresentation, or other contract or tort claims), will not exceed \$100; and (ii) PA, ISO-NE and their licensors will not be liable for consequential, special, incidental, punitive, indirect, or reliance damages, even if advised of the possibility of such damages.
- **8.** The laws of the State of New York will govern this License Agreement, without giving effect to any conflicts of law or other principles that would result in the application of the laws of a different jurisdiction.
- **9.** If any provision of this License Agreement is held to be illegal or unenforceable for any reason, then such provision shall be deemed to be restated so as to be enforced to the maximum extent permissible under law; the remainder of this License Agreement shall remain in full force and effect.
