New England Consumer Liaison Group (CLG) **ELECTION NOTICE** for Election of the Coordinating Committee to be held at the Quarterly Meeting December 4, 2024

Dear Consumer Liaison Group Member:

This Notice is to reiterate an announcement made at the September 12, 2024 Quarterly Meeting that the CLG will elect new members and/or re-elect current members of CLG's Coordinating Committee at the December 4, 2024 Quarterly Meeting. The meeting will be held at the Colonnade Hotel in Boston and virtually.

Anyone who has attended a CLG Quarterly Meeting in the past two (2) years is <u>considered to be a CLG member</u>. The Coordinating Committee is elected at a Quarterly Meeting every two (2) years for a two (2) year term. The committee elected in December will serve until December 2026 or until the first possible election date thereafter.

Any CLG member who is an electricity end-user or directly represents ratepayers, is a member of a consumer organization, or is a government consumer or ratepayer advocate is eligible to serve on the Coordinating Committee. There shall be at least **two (2)** members of the committee from each New England state, with a total of **fourteen (14)** members. Employees of ISO New England do not serve on the committee; although, they may be invited by the committee to participate in its meetings.

Any CLG member, including current committee members, may present themselves as candidates for election at the December 4<sup>th</sup> meeting. Any CLG member, including current committee members, may nominate another CLG member as a candidate for election.

The duties of a Coordinating Committee member are:

- to attend four (4) regular committee meetings a year each held on the same day as a CLG Quarterly Meeting and to participate in such special meetings (usually held virtually) as may be called by the chair;
- to participate in formulating overall CLG policy and particular meeting programs in accordance with FERC Order 719 and the CLG purpose and structure document;
- to offer feedback after CLG meetings, feedback to CLG email correspondence in between meetings, and to participate in preparation of the Annual Report;
- to participate in such other activities conforming to Order 719 and the purpose and structure document as may be requested by the committee, the chair, or their designee.

If you believe you qualify and are interested in being a candidate, please send Mary Berner a concise email or letter of interest and, if you wish, your resume by the deadline below. If you wish to nominate someone, please send Mary Berner an email identifying that person and explaining why you believe they would be a productive member of the Coordinating Committee. **Please also specify which New England state the nominee would represent, and whether they are a ratepayer (or directly represent ratepayers), a member of a consumer organization, a government consumer/ratepayer advocate, or a representative of commercial and industrial ratepayers.** A committee member or one of us will contact you to follow up on your expression of interest or nomination of another CLG member. The Coordinating Committee also will confirm that the individuals nominated are interested in serving on the committee.

Biographies of the nominees will be sent to CLG members in advance of the December 4, 2024 quarterly meeting. Voting will be available for both in-person and remote attendees at the December 4, 2024 quarterly meeting.
