Subject: Release of MIS report description, template and sample files for Sub-hourly RT Settlements, Fast Start Pricing and Dispatch, and Market Enhancements for DARD Pumps

ISO New England has released the final version of the MIS report description, template and sample files for market changes scheduled for implementation in March 2017: Sub-hourly Real-Time Settlements, Fast Start Pricing and Dispatch, and Market Enhancements for DARD Pumps. These reports also include revisions for the proposed March changes for NCPC- Dispatch Lost Opportunity Cost.

A new feature being introduced with Sub-hourly Real-Time Settlements is the five-minute trading interval. The hourly trading intervals will not change and will continue to be displayed in Hour End time. The subhourly five-minute trading intervals will be displayed in "Interval Begin" time, with hour end 01 having intervals 00:00 – 00:55.

The following reports replace the Draft versions previously posted on [12.01.2016](#). With the exceptions noted below, there were no changes between the Draft versions and the final versions.
