Instructions for Forward Capacity Auction 18

To participate as supply in the substitution auction of the Forward Capacity Market pursuant to Section III.13.2.8.2 of the ISO New England Transmission, Markets and Services Tariff (Tariff), or to be designated for treatment as a Renewable Technology Resource in the primary auction of the Forward Capacity Market pursuant to Section III.13.1.1.2.9 of the Tariff, the Project Sponsor must demonstrate that all of the definitional requirements of a Sponsored Policy Resource, as set forth on this form, are met. Use this form to provide the applicable information for each operational, under development, or proposed resource, including sufficient details for all underlying facilities included in the resource to meet the requirements. This form must be submitted to support any election to participate as supply in the substitution auction and any election for Renewable Technology Resource treatment.

A Project Sponsor electing to have the resource participate as supply in the substitution auction and also electing Renewable Technology Resource treatment must submit this form **twice**, as these are separate elections in the ISO's Forward Capacity Tracking System (FCTS). Uploading this form in FCTS as part of the documentation supporting the election of substitution auction participation will not serve as support for the election of Renewable Technology Resource treatment, and vice versa.

This form may only be used for the elections described above during the qualification process for FCA 18 and will be discontinued prior to the qualification process for FCA 19.
