Reference: Revisions to Offer Cap Requirements for Order No. 831

On June 14, 2019, ISO New England Inc. (ISO-NE) and the New England Power Pool (NEPOOL) Participants Committee together filed revisions to the ISO-NE Transmission, Markets and Services Tariff (Tariff) related to Order No. 831 compliance.<sup>1</sup> You state that the revisions amend the dispatch treatment of price-capped supply offers in the day-ahead energy market and move the effective date for all of ISO-NE's revisions for compliance with Order No. 831 from October 1, 2019 to March 1, 2020.

Pursuant to the authority delegated to the Director, Division of Electric Power Regulation – East, under 18 C.F.R. § 375.307, your submittal is accepted for filing, effective March 1, 2020, as requested.

The filing was noticed on June 14, 2019, with comments, interventions, and protests due on or before July 5, 2019. Pursuant to Rule 214 (18 C.F.R. § 385.214 (2018)), to the extent that any timely filed motions to intervene and any motion to intervene out-of-time were filed before the issuance date of this order, such interventions are granted. Granting late interventions at this stage of the proceeding will not disrupt the proceeding or place additional burdens on existing parties.

This acceptance for filing shall not be construed as constituting approval of the referenced filing or of any rate, charge, classification, or any rule, regulation, or practice affecting such rate or service contained in your filing; nor shall such acceptance be deemed as recognition of any claimed contractual right or obligation associated therewith; and such acceptance is without prejudice to any findings or orders which have been or may hereafter be made by the Commission in any proceeding now pending or hereafter instituted by or against ISO-NE or NEPOOL.

This order constitutes final agency action. Requests for rehearing by the Commission may be filed within 30 days of the date of issuance of this order, pursuant to 18 C.F.R. § 385.713.
