Submission Instructions:

All three self-certifications must be filled out completely, signed and dated prior to the close of the New Capacity Show of Interest Submission Window. The completed certifications must be uploaded to the Forward Capacity Tracking System (FCTS) under the "Self-Certifications" document upload field shown in Step 5 of the Show of Interest submission process.

Failure to complete any of the certifications in this package may result in the rejection of your New Capacity Show of Interest Form.

Interconnection Application Certification

In accordance with Section III.13.1.1.2. of the ISO Tariff, the Project Sponsor (or Lead Market Participant) must have, prior to the close of the New Capacity Show of Interest Submission Window, a valid Interconnection Request for the new Generating Capacity Resource under Schedules 22, 23 or 25 of the OATT. However, in cases where the resource's point of interconnection is NOT subject to the OATT, the state interconnection process applies and an interconnection application with the local distribution company is needed an Interconnection Request with the ISO. instead of By executing this form, the Project Sponsor or Lead Market Participant certifies that the listed resource is interconnecting to a distribution facility that is not subject to the OATT and, accordingly, in order to meet the requirements of Section III.13.1.1.1 of the ISO Tariff, it has a valid interconnection application with the local distribution company.
