Introduction

Each day, ISO-NE generates and distributes thousands of detailed reports supporting the operation of the bulk power system and the settlement of wholesale electricity markets under New England's Standard Market Design. These reports are generated within our Market Information Server (MIS) and distributed to participants via Secure File Transfer Protocol (SFTP) technology. Throughout our business, these reports are referred to as MIS reports.

This document provides a listing of MIS reports and includes related availability and retention. It also provides miscellaneous information pertaining to all reports.

As indicated by the page title, the page also includes report descriptions, templates and sample files to assist participants in their understanding of the data provided and should be explored by MIS users.



IMPORTANT

The MIS FTP server is designed to transfer distributed reports, and it is not intended as a repository. Participants should download the reports they deem necessary for their back office or settlement functions, and retain copies as per their own retention policies and needs. While the ISO maintains records per its own record retention policy, the files are only available on the MIS FTP servers for the periods noted in the MIS Report Retention schedule below.

Accessing MIS Reports

MIS reports are available to participants via ISO New England's FTP file server. Security Administrators manage company and user specific FTP account access and can provide users with required credentials.

Formatting MIS Reports

MIS reports are provided in a Comma Separated Value (CSV) format, compressed into a .zip file and sometimes additionally compressed into a .gz g-zip file.

Although the CSV format is convenient for providing data, is not the most convenient file type for viewing manually. ISO-NE provides a report formatting utility that leverages Microsoft Excel and a suite of ISO-NE templates. The utility runs in Excel and applies the applicable template to the CSV file and provides the reader with nicely formatted and readable reports.

Standard Settlement Additional Detail

Standard Settlement reports have been historically implemented by the ISO to allow for a quick implementation of short notice reporting needs as well as in support of market implementations which are temporary in nature. These reports share a standard format.

Each Standard Settlement report may contain three sections = Calculation, Allocation, and Additional Information. Note that the provided SS_GENERICSS report is a Standard Settlement sample file and not an actual report file. It should be used solely as a guide. The Generic Report Description is provided to display all columns and corresponding definitions that could be found in any of the Standard Settlement reports.

The specific report descriptions for the Standard Settlement MIS reports display only those columns and corresponding definitions for those columns populated by the specific Standard Settlement item. All remaining columns will be included with blank values.

The Additional Information section of each Standard Settlement report is neither defined in the Generic Report Description nor the Specific Report Description as it provides supplemental information, as needed, which was previously provided in the Bill Job Aid. All text fields have a 200 character maximum.

Report Redistribution

The report retention periods outlined in the MIS Report Retention table below represent the time period that a report will remain available within a participant's MIS FTP account. The ISO can redistribute these reports beyond these retention periods, for a period up to two years from their distribution. Requests for redistributed reports may be submitted to Participant Support &Solutions via Ask ISO at https://askiso.iso-ne.com/s/contactsupport or via e-mail at AskISO@iso-ne.com.

Please note that report redistribution requests should be by exception and not part of normal business process. We recommend that companies routinely download all relevant MIS reports prior to their retention expiration.

File Naming Convention (including Standard Settlements)

MIS report file names are determined using the following format:

Report Name = report type_report name_customer id_yyyymmddhh_yyyymmddhhmmss

Where the first date mask in the report name represents the market day and the second date mask represents the timestamp of the report generation, in GMT time.

Example:
